AND

Ltd {Private Limited Company} incorporated under the provisions of the Companies Act 1956 having its registered office at 1/1 Pollock Street, Kolkata and represented through **Mr. Girish Singhania** (Hereinafter referred to as the "Training Service Provider" or "TSP") which expression shall, unless repugnant to the context, include its successors, heirs, permitted assigns, representatives, hereinafter called the 'Second Party'.

WHEREAS

The First Party is a College established in 1966 at **Sir M V Road, Basaveshwara Circle, Shivamogga-577201** and is mandated to increase the employability of the youth through introduction of Advanced IT programme through skill development viz. Advanced IT courses.
